
OFFICE ORDER

Sub: Centre for Advanced Technology (CAT),
Indore.

The Department of Atomic Energy had accepted the recommendations of the Committee on High Energy Accelerators. In order to implement these recommendations, the Centre for Advanced Technology (CAT), Indore and the Variable Energy Cyclotron Centre (VECC) at Calcutta, would be the most appropriate institutions, while BARC and TIFR will also make contributions in terms of technology and scientific manpower. In order to speed up the implementation of the programme it is now decided to constitute a Steering Committee for Accelerators and High Technology whose composition is as given in the Annex. In order to pursue vigorously the programme, it is necessary that approval and monitoring are done effectively and speedily in the Department of Atomic Energy. It is therefore, decided that the Secretary, DAE, will not only chair this Steering Committee but the Directors of these two institutions will independently report to the Department. The two institutions will, however, continue to effectively interact with BARC by involving active scientists in the various programmes as well as Sub-Committees and Task Forces appointed for this purpose.

This is in partial modification to this Department's Office Order No.5/24/87/BARC/R/665 dated May 6, 1988.



OFFICE ORDER

In continuation of DAE Office Order No.5/24/87 (BARC)/R/123-90 dated 15th February 1990, Director, Variable Energy Cyclotron Centre will exercise the powers of a Head of a Unit under the Department of Atomic Energy. He will also submit his budget and other matters for approval to the Department of Atomic Energy. He will constitute a Scientific Committee consisting of Group Leaders representing various Task Groups. This Committee will take all decisions with respect to VECC. Matters of policy and new projects will be referred to the Steering Committee constituted by the above order. In order to maintain close collaboration in scientific activities, the Scientific Committee of VECC and the Physics Group Board of BARC will have mutual representation. Director, VECC is authorised to constitute the Scientific Committee of VECC.
