Terms & Conditions of Tender:

- 1. Completion Time of the work:
 - a. The estimated completion time of the job is 14 days from the issue of work order. For works to be done inside VECC premises the completion time will be counted from the date of issue of applicable documents like safety permit, security clearance.
 - b. Penalty @0.5% per week subject to maximum 10% of Work Order value will be levied on in case of delay beyond stipulated completion period.
 - c. In case the vendor is not able to execute the job as per the specifications and within the stipulated time, the Department reserves the right to cancel the work order and recover such compensation for delay as applicable.
- 2. Documents to be submitted along with the tender: Copies of **valid** PAN and GST.
- 3. The Contract shall comply with all Central, State and Municipal laws and rules and shall be solely responsible for complying with the provisions of the Contract Labour (Regulation and Abolition) Act, 1970, and the rules there under and the other enactments that may be applicable including the Payment of Wages Act, 1936, Factory Act 1948, Workmen's Compensation Act, 1923 or any other applicable legislation and Municipal Bye-laws or other Statutory rules and regulations, whatsoever, in force. In so far as these are applicable, any obligations, financial or otherwise, imposed under any statutory enactments, rules and regulations, there under shall be the sole responsibility or the contractor. The service provider shall be liable for ensuring compliance with the provisions of all applicable laws including but not limited to Labour Law[Central/State] and specially Workmen Compensation Act. The onus of compliance to all the applicable Laws/Acts/Rules shall rest with the service provider only and the buyer will not be liable in any manner.
- 4. The persons deployed by the service provider shall solely be the responsibility of the service provider and buyers shall have no obligation for any sort of claims raised by the service provider's employees/personnel. For all intents and purposes, the service provider shall be the "Employer" within the meaning of different Labour Legislations in respect of manpower so employed and deployed in the buyer's premises and shall be responsible to fulfil all obligations under applicable laws without any recourse to the buyer.
- 5. The vendor should promise to abide by all security rules and norms as applicable to VECC during the execution of work inside VECC campus. The vendor should not divulge any information relating to VECC and / or Department of Atomic Energy to any person whosoever.

Payment terms:

- 1. Single & final payment will be made by NEFT/RTGS only after satisfactory completion of the work.
- 2. Payment will be made within 30 days after the submission of (a) invoice, (b) Satisfactory completion certificate issued by the Engineer in-charge and (c) Bank details of the vendor for making the online payment.
- 3. It may be noted that applicable taxes at the prevailing rate will be deducted and certificate for same will be uploaded by PAO, VECC.
