CHSS - KOLKATA

Sub : Recognition of CGHS approved hospitals located in Kolkata

This is to notify that beneficiaries under CHSS, Kolkata may avail of the medical treatment (both OPD & Indoor which include investigations, procedures, etc.) from the CGHS approved hospitals as per Annexure-I.

The terms & conditions to avail of medical treatment from the CGHS approved hospitals are as follows :

1. Credit facility is not allowed. Hence, beneficiaries are required to make direct payment to these hospitals.
2. CHSS beneficiaries may avail of medical treatment from these hospitals as per Annexure-I after making payment directly and submit claim for reimbursement within 3(three) months after completion of treatment.
3. Beneficiaries may avail of medical treatment from these hospitals directly without any referral.
4. For the purpose of availing Indoor medical treatment from these hospitals, entitlement of bed are is follows :

Category (as mentioned in CHSS Card)

'A' & 'B'

'C'

'D'

Entitlement of bed

General Ward

Semi Private Ward

Private Ward

5. Reimbursement will be made on par with CGHS rates. Therefore, beneficiaries may kindly ensure that each original Bill/Cash Receipt bears the following remarks recorded by the hospital : **"Bill/Cash Receipt is prepared on par with CGHS rates only"**.
6. Medicines prescribed by these hospitals will have to be purchased by the CHSS beneficiaries on their own and submit claim for reimbursement.
7. No medical advance under any circumstances will be given by this Centre for taking medical treatment in these hospitals.

This will take effect from **01.8.2004**.
