C I R C U L A R
CHSS, KOLKATA

The following decisions have been taken for the beneficiaries under CHSS, Kolkata :

1. Medicines shall also be available at the following medicine shop on credit basis w.e.f. 26.4.2004 :

M/s. MEDICURE

Shop No.9, AG Block, Sector-II, Kolkata - 700 091

2. Dental treatment (both OPD & Indoor) shall not be available on credit basis at AMRI Hospitals/Clinic w.e.f. 26.4.2004.


However, a transition period of one month from 26.4.2004 to 25.5.2004 is allowed for the patients who are under continued Dental treatment in AMRI Hospitals/Clinic prior to 26.4.2004. Credit facility shall be allowed during the transition period only. But this transition period shall be valid upto 25.5.2004 only.

Beneficiaries under CHSS, if they so desire, may avail Dental treatment at AMRI Hospitals/ Clinic after making payment. In that case expenditure incurred at the said Hospital/Clinic shall be reimbursed by this Centre strictly according to the prevailing rate of Mission of Mercy Hospital & Research Centre Kolkata (i.e. Base Hospital under CHSS, Kolkata)

3. In supersession of this Centre's Circular No.VECC/ADMIN/CHSS/2003/1051 dated 25.3.2003 purchase of medicines shall be allowed for the period of maximum one month at a time on credit basis on the basis of the prescription of Medical Officer, VECC, recognised Hospitals/Polyclinics from the recognised medical shops (viz. M/s. Dhanwantary, M/s. New Dey's Medicure & M/s. Medicure) w.e. 26.4.2004. In the event of medicines being prescribed for more than one month against a single prescription, the 2nd batch of supply will be made on or after 25th day only.

All other terms & conditions governing medical beneficiaries under CHSS, Kolkata shall remain unchanged.

This issues with the approval of Director, VECC.
