C I R C U L A R
CHSS - KOLKATA

Reference is invited to this Centre's Circulars dated 08.10.2004 and 08.11.2004 regarding the Medical Scheme of this Centre. The following additions to the Medical Scheme will be implemented w.e.f. 01.01.2005 until further notification :

- 1) **Medical treatment/medical investigations** which are not listed under any head of CGHS, the corresponding rates at the Base Hospital or actual whichever is lower, would apply for the purpose of reimbursement and credit. In the event of items not available at Base Hospital, the actual rates would apply.
- 2) **Dental treatment will not be available at AMRI Hospitals, Kolkata under credit facility w.e.f. 01.01.2005.** For treatment taken at any Dentistry (outdoor only) as per this Centre's Circular dated 08.10.2004, reimbursement would be as per CGHS rates. Those rates which are not listed under any head of CGHS, the corresponding rates at the Base Hospital or actual, whichever is lower, would apply for the purpose of reimbursement and the rates which are not available at Base Hospital, the actual rates would apply.

Investigations, however, can be carried out at any investigation centre at the choice of the beneficiaries as per Circular dated 08.10.2004 and reimbursement would be made as per CGHS rates or actual, whichever is lower. Those items which are not listed under any head of CGHS, the corresponding rates at the Base Hospital or actual, whichever is lower, would apply for the purpose of reimbursement. In the event of items not available at Base Hospital, the actual rates would apply.
