W A L K - I N - I N T E R V I E W

A Walk-in-Interview will be held on **8th June, 2011 (Wednesday)** at Variable Energy Cyclotron Centre (VECC), Department of Atomic Energy, 1/AF, Bidhan Nagar, Kolkata - 700 064 (near CAP Camp Bus Stop, Saltlake) for engagement of **1 (one) no. of Consultant Physician** for Regional Radiation Medicine Centre, Thakurpukur (a unit of VECC, Kolkata). Aspiring candidates are requested to report to The Administrative Officer-III, VECC by **9 A.M.** positively on **8th June, 2011 (Wednesday)**. Candidates reporting after **9:00 A.M.** will not be considered under any circumstances. The details are as under:

Duration of engagement	For a period of 3 (three) years purely on temporary basis (on contract). Initially for a period of one year extendable for a further period of 2 (two) years depending upon requirement and performance.
Educational Qualification	M.B.B.S. degree recognized by Medical Council of India.
Experience	Candidates having experience in the field of Nuclear Medicine will be given preference.
Age limit as on 08.06.2011	General category candidates should not be more than 27 years of age. However, SC/ST/OBC candidate(s) will get upper age relaxation as per rules i.e. OBC candidates should not be more than 30 years of age and SC/ST candidates should not be more than 32 years.
Remuneration	₹.26,000/- (Rupees Twenty six thousand only) per month (Consolidated).
Posting of selected candidate	Regional Radiation Medicine Centre, Thakurpukur, Kolkata (a unit of VECC, Kolkata).
Candidate should follow :	On the date of " Walk-in-Interview ", the candidates shall report at the venue alongwith duly filled-in application form in the format appended below, one passport size photograph duly affixed and attested by a Gazetted Officer, attested copies of the testimonials regarding date of birth, qualifications, experience, caste, "No Objection Certificate" from the present employer, etc. Candidates should also bring originals of all the said documents for verification, failing which they shall not be allowed to appear for the interview. SC/ST/OBC candidates shall bring their latest caste certificate issued by the Competent Authority in the prescribed format.

General Conditions :-

1. The appointment is purely contractual and will not confer any right on the candidate to claim for regular appointment in VECC or in any other unit of Department of Atomic Energy or for continued contractual appointment.
2. Candidates who are working under the Central/State Govt./Public Sector Undertakings shall mandatorily bring NOC from their present employer.
3. SC/ST candidates admitted for Interview will be paid Travelling Allowance as per the extant rules.
4. Candidates must bring a valid Photo Identity Card (viz. Voter's Identity Card or Driving Licence or Personal Passport or Identity Card issued by their respective educational institution etc.) in original, while appearing for the interview, failing which they will not be allowed to enter the VECC premises.
5. Efforts will be made to complete the interview of all the candidates on the scheduled date itself i.e. 08.06.2011. However, if all the candidates could not be interviewed on the said date, remaining candidates would be interviewed on the next day i.e. 09.06.2011. Candidates are, therefore, required to come prepared accordingly.
6. During the validity of contract, the Consultant Physician will be at liberty to terminate the contract for betterment of career or for any other ground by giving prior notice of 1 (one) month to VECC. In the same manner the contract can be terminated by VECC by giving a prior notice of 1 (one) month to the Consultant Physician, without assigning any reason whatsoever.

VECC reserves the right to cancel the whole process for engagement of Consultant Physician, without assigning any reason.
