**Engagement of Project Associate-I & Principal Project Associate for the GRID Computing Facility at VECC, Kolkata purely on temporary basis.**

VECC is inviting applications from Indian nationals for filling up **TWO (2) Project Associate-I (PA-I)** and **ONE (1) Principal Project Associate (PPA)** purely temporary positions (co-terminus with the project) for a period of **TWO (2)** years in the first instance and may be extended up to a maximum of **Two (2)** years after performance reviews.

In this regard, applications are invited from willing and eligible individuals for inducting them on purely temporary basis for the following posts on consolidated remuneration. Terms and conditions, eligibility criteria and other necessary details for engaging the young professionals shall be as under:

- Categories to be engaged: Project Associate-I (PA-I)** and **Principal Project Associate (PPA)**(in Computer Science and Engineering or equivalent).
- Target group:** The candidates as per eligibility criteria specified at point-3.

4. **Duration of Engagement/Induction:** The terms of engagement/induction shall be for a period of two years, extendable for two more years, as per the functional need. The period can also be curtailed based on performance evaluation. All extant provisions/instructions of Government of India etc. shall be strictly followed and the engagement/induction shall be purely temporary in nature. Therefore, mere selection of the candidate to the above post shall not confer him/her a right to claim for regular employment/absorption in VECC, Kolkata.

#### 6. Declaration of Secrecy:

All professionals engaged/inducted will be required to furnish oath of secrecy in prescribed format at the time of reporting for induction.
